- 2. The service provider should have sufficient experience in providing Motorcabs and Maxicabs in Government, Public sector or reputed Private Sector offices during the last three financial years. Experience certificate clearly indicating i) name of the organization ii) period of work iii)the value of work iv) nature of work carried out by the agency should be submitted in support of experience.
- 3. The AC or Non AC Motorcab and Maxicab provided by the agency should have commercial registration/certificates from Motor vehicle authorities.
- 4. The Corporation shall not make any payment for consumption of fuels required for the cars and pay & overtime of driver.
- 5. The cabs will be normally engaged by the Corporation for official purpose and shall have to go throughout the State of West Bengal.
- 6. THAT the hired cabs shall be maintained properly and kept in good condition by the car owner. The seat cover and towels should be provided by the car owner and in case of breakdown, another cab of same condition as the original car should be provided to the Corporation as replacement by the said owner. If the owner fails to provide the substitute cab, the Corporation shall be at liberty to hire any other car from the market and the owner shall be liable to reimburse the additional expenses incurred by the Corporation.

- 7. The arrangement for garage, maintenance and repair of car shall be carried out by the car owner at his own cost.
- 8. That the mileage for garage shall be allowed for a distance of 10(ten) K.M.(both ways) and duty hours will be counted from the time of reporting and release.
- 9. That the owner shall at all times keep the cars fully insured against whatsoever claims that may arise.
- 10. That the Corporation shall not be liable for any claims made by third parties due to any accident caused by the hired cars.
- 11. The Corporation reserves the absolute right to accept or reject any or all quotations without assigning any reason thereof.
- 12. Payment will be made through A/C Payee Cheque or through Bank A/C against the submission of the bill in duplicate along with duty slip duly signed by the authorized officer.
- 13. The contract would be initially for a period of 12(twelve) months starting from the date of execution of the agreement. If the tenderers's service is found satisfactory, the contract with the service provider may be extended on year to year basis with mutual agreement. However, if any deficiencies are noticed during the currency of the contract period or any contractual dispute, the contract can be terminated by giving one month's notice.
- 14. The Corporation reserves the right to reduce or terminate the period of contract or to extend its duration in the interest of Corporation for any justifiable reasons, not mandatory to be communicated to the tenderer.
- 15. After awarding the contract, the service provider shall enter into an agreement for performance of the contract with the Corporation.
- 16. If the contract is terminated on the grounds of deficiencies during the currency of its tenure or its extended tenure, if any, the Corporation shall have all rights to make alternative arrangements for a period of 45 days from the date of such termination or till a new quotation is finalized whichever is earlier and the difference in cost, if any shall be borne by the agency.
- 17. Permission as laid down in Transport Department G.O. No. 3564-WT /3M-81/98 dated 24.11.2008 and subsequent amendment thereof shall be applicable.
- 18. In case of hiring of a vehicle for more than 10 days in a month or hiring of vehicle in a regular manner the rate of hiring should be on monthly rate on prorate basis.

Annexure-III

Instruction to Bidders

- 1. The Tender along with attested copies of valid Trade License, P.A.N., Service Tax Return, Proof or certificate of Experience and satisfactory Performance certificate, Proof of registered office in Kolkata in case of Private or Public Ltd. Company must reach this office within 1 P.M. on 21.11.2017
- 2. The rate should be quoted on monthly basis both in figures and in words inclusive of all taxes applicable in West Bengal.
- 3. The Tender shall be valid for 1(one) year from the date of opening of Financial bid
- 4 The tenderer is being permitted to give tenders in consideration of the stipulation on his part that after submitting his tender he will not resign from his offer or modify the terms and conditions thereof.
