Airconditioner machines including necessary electrical installation and wiring. The interested Companies/Firms/Agencies may send their bid complete in all respect along with and other requisite documents to the undersigned duly superscripted "installation of three nos. Airconditioner machines including necessary electrical installation and wiring." before 1600 hrs on 06th June 2019. The bids received after this deadline shall not be entertained under any circumstances whatsoever. NOTE: The EMD draft should be put in the envelope containing Technical Bid failing which the tender/quotation shall be rejected forthwith.

- 3. The sealed envelopes are to be deposited in the tender/quotation box placed at the office of the undersigned. Bids sent by COURIER will not be entertained.
- 4. Bids will be opened on 06.06.2019 at 16.30 hrs in the presence of bidders or their authorized representatives who wish to participate in the bidding process with authorization letter. If the opening date happens to be a closed day/holiday, the tender/quotation will be opened on the next working day.
- 5. Any future clarification(s) and / or corrigendum(s) shall be communicated by the CSPO & Ex- Officio Executive Engineer In Charge.
- 6. Managing Director, West Bengal State Seed Corporation Ltd., reserves the right to amend or withdraw any of the terms and conditions contained in the Tender/quotation/Quotation Document or to reject any or all tender/quotations/Quotation without giving any notice or assigning any reason. Eligibility Criteria for Qualifying in Technical Bid The agency should meet the minimum eligibility criteria:

- 1. A minimum experience of two years in the field. Valid documents in support of experience must be attached.

- 1. The bid should contain all the relevant information and desired enclosures in the prescribed format In case.
- 2. The Contracts concluded as a result of this Tender/quotation Inquiry shall be governed by the 'Terms & Conditions' and other relevant instructions as contained in this Tender/quotation Document.
- 3. The Tender/quotations should be typewritten or handwritten but there should not be any overwriting or cutting. Correction, if any, shall be made by neatly crossing out, initialing, dating and rewriting. The name and signature of bidder's authorized person should appear on each page of the tender/quotation. All pages of the tender/quotation document shall be numbered and submitted as a package along with forwarding letter on agency's letter head.
- 4. Bidders are requested to quote their prices on a firm & fixed basis for the entire period of the Contract. Bids of the firms received with prices quoted on variable basis shall be rejected straightaway.
- 5. Refund of Earnest Money Deposit: The EMD submitted if any by unsuccessful bidders shall be returned to them without any interest whatsoever, within 15 to 90 days after conclusion of the contract with successful bidder. - 3. Single rate to be quoted in compiled form for one unit of the implements mentioned above in words and figure clearly, including carrying, loading, unloading packing etc. charges, GST and other taxes if applicable. Offered rate should also include with Installation, Demonstration charges.
- 4. Copies of PAN Card, income tax return certificate, GST Registration Certificate, Current Trade License, up to date Professional Tax deposit challan on trading/state tax as applicable, credentials, etc., should be submitted with the quotation.
