Bidders quoting L1 rate within the admissible amount shall be entitled for selection.

2. The AC Maxicab or AC Motorcab provided by the agency should have commercial registration/certificates from Motor vehicle authorities.
3. Every bidder participating in the bidding process must submit an affidavit(Notarised) in a Non-Judicial Stamp Paper of Rs. 10/- denomination containing a self declaration stating that "the participating bidder has not been convicted/blacklisted by any Government organization/semi or quasi Govt. organization/Corporation of GOI or any other State Government in the country during the last three years". Suppression of facts/events happened during the period in question shall invite punishment to be decided by the Corporation along with disqualification from bidding process.
4. The cabs will be normally engaged by the Corporation for official purpose and shall have to go throughout the State of West Bengal.
5. THAT the hired cabs shall be maintained properly and kept in good condition by the car owner. The seat cover and towels should be provided by the car owner and in case of breakdown, another cab of same condition as the original car should be provided to the Corporation as replacement by the said owner. If the owner fails to provide the substitute cab, the Corporation shall be at liberty to hire any other car from the market and the owner shall be liable to reimburse the additional expenses incurred by the Corporation.
6. The arrangement for garage, maintenance and repair of car shall be carried out by the car owner at his own cost.
7. That the mileage for garage shall be allowed for a distance of 10(ten) K.M.(both ways) and duty hours will be counted from the time of reporting and release.
8. That the owner shall at all times keep the cars fully insured against whatsoever claims that may arise.
9. That the Corporation shall not be liable for any claims made by third parties due to any accident caused by the hired cars.
10. The Corporation reserves the absolute right to accept or reject any or all tenders without assigning any reason thereof.

11. Payment will be made by means of RTGS/NEFT through Bank A/C against the submission of the bill in duplicate along with duty slip duly signed by the authorized officer.
12. The contract would be initially for a period of 12(twelve) months starting from the date of execution of the agreement. If the tenderer's service is found satisfactory, the contract with the service provider may be extended on year to year basis with mutual agreement. However, if any deficiencies are noticed during the currency of the contract period or any contractual dispute, the contract can be terminated by giving one month's notice.
13. The Corporation reserves the right to reduce or terminate the period of contract or to extend its duration in the interest of Corporation for any justifiable reasons, not mandatory to be communicated to the tenderer.
14. After awarding the contract, the service provider shall enter into an agreement for performance of the contract with the Corporation.
15. If the contract is terminated on the grounds of deficiencies during the currency of its tenure or its extended tenure, if any, the Corporation shall have all rights to make alternative arrangements for a period of 45 days from the date of such termination or till a new quotation is finalized whichever is earlier and the difference in cost, if any shall be borne by the agency.
16. If the successful bidder fails to provide service to the Corporation in spite of repeated reminders then the Corporation shall reserve the right to engage any other car service provider in order to avoid disruption of service and the contract with the successful bidder shall be liable for cancellation and the Earnest Money Deposit(EMD) will be forfeited. In such a case, the authority shall have the right to debar the successful bidder or the car service providing company or any new company formed by him at a future date from participating in the tender(s) that may be invited by the Corporation (WBSSCL) during the next 3(three) years.
- 17.(a) If the event of failure to provide service by the L-1 car service providing agency in spite of repeated reminders, the L2 bidder will be offered to provide the car at the rate quoted by the L-1 bidder.

(b). If the event of failure to provide service by the L-1 and L-2 car service providing agency, the L3 bidder can be offered to provide the car at the rate quoted by the L-1 bidder.
18. Permission as laid down in FD Memo No. 4100-FB dated 13.12.2000 read with Transport Department Notification NO. 3564-WT/3M-81/98 dated 24.11.2008 and subsequent amendment thereto from time to time shall be applicable.
19. In case of hiring of a vehicle for more than 10 days in a month or hiring of vehicle in a regular manner the rate of hiring should be on monthly rate on prorata basis.
20. The responsibility of guarding the hired vehicles for any loss, theft etc. will rest upon the supplier of the hired vehicles. WBSSCL will also not be held responsible for the following:-
 - iv) Any damage caused due to accident.
 - v) Compensation, if any awarded by the Court in the case of traffic violation of the car and its drivers.
 - vi) Any taxes or charges that may be levied by the State Government/Central Government.

21. The vehicles will not be used usually on Sunday or holidays if not specially requisitioned. If the supplier fails to supply on requisition, for whatever reasons penalty equivalent to two times of daily hiring charges may be imposed on the supplier of the vehicle for each case of failure to supply vehicles.
22. The servicing of vehicles should be done by the supplier at his own cost with prior intimation so that duty may be adjusted.
23. The hiring charge quoted by the agency shall be fixed for the period of the contract and no request for escalation of rate shall be entertained before expiry of the period of the contract
24. The successful bidder shall abide by the terms and conditions laid down in G.O. No. 3564-WT /3M-81/98 dated 24.11.2008 issued by the State Government.

Annexure-I

Eligibility and Experience Criteria

5. Any individual, sole proprietorship firm, Partnership firm, Limited or Private Limited Company having office in India can participate in the Re-Tender.
6. The AC Motorcab and AC Maxicab to be provided by the agency should have commercial registration certificates from Motor vehicle authorities.
7. The AC Motorcab and AC Maxicab to be provided by the agency should be vehicles not more than 4 years of age.
8. The AC Motorcab and AC Maxicab to be provided by the agency should have Auto emission testing certificate and upto date Tax Clearance.
