Notice inviting e-tender No. 01, Dated 02/07/2018 of the West Bengal State Seed Corporation Ltd., Malda from reputed and experienced Transporter having valid trade license on transport work for Transportation of different type of seeds and other related agricultural inputs from WBSSC Ltd., Malda godown to different blocks of Malda, districts and to other districts of the West Bengal and also to the neighboring states and vice versa. Estimated value of this tender is tune of **₹26,00000/- (Rupees twenty six lakhs only)** on an average per year.

The Financial proposal of the prospective tenderer will be considered only if the technical bid of the tender is found qualified by the tender evaluation committee, the decision of the tender evaluation committee, will be final and absolute in this respect. The list of qualified bidders will be displayed in the website. The authority may have asked to for submit all original documents for verification after opening of financial proposal of L1 bidder.
3. Seed and other materials may be loaded and unloaded at one or more points as will be directed by the corporation and single point in case of transport for outside states. In case of outside state loaded quantity of input should not be exceed 9.0 MT for which insurance covered stock will be transported.
4. No haul targe and demurrage charges will be provided from the corporation.
5. For any transit loss in quality & quantity like shortage, pilferage, damage, rain soaking etc. the cost of seed will be deducted from the bill as per selling price of seed and inputs.
6. If the selected transporter unable to provide vehicle within 12 hours of instructions, the under signed reserves the right to arrange vehicle from open market at any rate and excess bill amount of the said carrying bill will be adjusted from the bill of contractor.
7. The selected transporter should visit office regularly 2 times to collect information regarding transportation schedule at 10:30 A.M. & 4:00 P.M. respectively.

Upon acceptance of the tender by **WEST BENGAL STATE SEED CORPORATION LIMITED, Malda, ₹2,60,000/-** (Rupees two lakhs sixty thousand only) mandatorily deposited by the party as security deposit (10% of tender value) within 15 days after issuing of work order and EMD of **₹52,000/- (Rupees fifty two thousand only)** will be adjusted as Security deposit. WBSSCL reserves the right to forfeit the Security Deposit (in part or full) in the event of failure of the transporter to comply with the terms of contract. The Security Deposit or such part thereof has not been forfeited or adjusted will be refunded to the transporter only on expiry of the contract and on satisfactory completion of the work under the agreement and on production of no due / no demand certificate from the consignor unit of WBSSCL relevant to the contract period and after deducting the outstanding dues, if any, against the transporter on account of shortages, damages, delayed delivery etc. WBSSCL reserves the right to forfeit the Security Deposit in the event of failure of transporter to produce acknowledgement copies of the challan receipts / consignment notes from the consignees or execute the transportation job to the WBSSCL's satisfaction. **Hard copy of demand draft submitted to office of the undersigned for said transport tender by successful tenderer.**
10. The intended Bidder must submit rates (including loading, unloading, other incidental charges and insurance charge etc. in specified BOQ only).
 11. Necessary T.D.S. will be deducted from the bill of Contractor as per Govt. rules.
 12. Corporation will not be responsible for any type of prosecution made by the Traffic Police Authority against Transporter while in transit and cost of material will be realized from the Transporter's bill & security deposit, if there be any loss of Corporation.
 13. The bill for carrying will be paid quarterly on the basis of receipted challan subject to availability of fund but bill must be placed to this office monthly.
 14.  15. The Transport Contract period will be at least for one year & no enhancement of rate will be allowed for that period due to hike of price of diesel spare parts etc. it may be extended for further one year if both the Corporation & Transporter agreed.
 16. In some of the cases the unloading Charges varies from the quoted rate for such Condition transporter has to produce the relevant voucher of unloading duly certified by Assistant Director of Agriculture of that Block, Savapati/Pradhan with Stamp in exceptional circumstances only for delivery of stock for remote & Hill area.
 17. The envelope should be superscripted as Tender for Transportation for West Bengal State Seed Corporation Ltd., Malda.
 18. The Transportation Charges will be paid on the basis of Distance covered × Weight × Rate on one way transportation of each consignment.

21. All Challans issued / received on the same date to a particular route must be treated as a single consignment a weight is to be considered of each consignment as a whole. All receipted Challan will have to be deposited within 7 days of delivery.
22. **The Bidder who have quoted lowest rate in maximum numbers of items preference will be given to him, provided he accepts in writing to execute the whole contract on the basis of lowest rate (L1) of all items. The contractor or his representative has to be present at the time of loading & unloading.**
23. Misconduct, misbehavior with the Staffs and Officers and with any customer, the Corporation reserves absolute right to terminate the contract on or before the contract period.
24. All specified work including loading & unloading is to be completed within 10.30 AM to 6.00 PM in general and time may be changed on emergency period as per direction of corporation's authority.
25. All statutory document are to be submitted in soft copy only, hard copies are not entertained by the office. If any statutory documents are not to be submitted by any bidder within above mentioned time frame their proposal will be liable for rejection.
26. All Court case if any raised in subject to jurisdiction of Kolkata.
27. All original tender documents & processing fees, EMD of L1 Bidder will be submitted to this office before issue of Award of contractor for said transport work.
28. Loading instruction as per Motor Vehicle Act. Should never be avoided and no risk would borne by the corporation regarding violation of said Act.
29. In no circumstances contractor will stop transportation work as directed by the authority, failing which security deposit of contractor will be forfeited and contract will be terminated forth with before the end of contract period with punishment for not to allow participation in future tender of this corporation. Besides this for misconduct with all officials & delay in service of the contractor, the authority reserves right to terminate his transport contract before the end of contact period.
30. An agreement on Non-judicial stamp of ₹10/- (Ten) transport contract as per tender terms & condition as laid down in this tender must be made by the successful contractor within seven(7) days of A.O.C. letter.
31. The authority reserves the absolute right to accept or reject any tender either full or part of all tender without assigning any reason or may impose further condition if it is found deems necessary in future.
32. The rate should be quoted in BOQ inclusive of loading, unloading, stacking charges, all applicable taxes & incidental charges at FOR delivery.

INSTRUCTION TO BIDDERS

General guidance for e-Tendering:

Instructions / Guidelines for electronic submission of the Tenders have been annexed for assisting the Contractors to participate in e-Tendering.

☞ **Registration of contractor :**

Any contractor willing to take part in the process of e- Tendering will have to be enrolled & registered with the government e-procurement System, through logging on to <https://wbtenders.gov.in> then Contractor is to Click on the link for e-Tendering site as given on the web portal.

☞ **Digital Signature Certificate (DSC) :**

Each Contractor is required to obtain a Class- II or Class-III Digital Signature Certificate (DSC) for submission of Tenders from the approved Service provider of the National Informatics Center (NIC) on payment of requisite amount. Details are available at the Web Site Stated in clause A.I. above. DSC is given as a USB e-Token.

☞ The Contractor can search and download N.I.T. & Tender Document (s) electronically from Computer once have logs on to the Website mentioned in Clause A.I. using the Digital Signature Certificate. This is the only mode of Collection of Tender Documents.

☞ **Submission of Tenders :**

Tenders are to be submitted through online to the Website Stated in Clause A.I. in two folders at a time for each work, one in technical Proposal & the other is financial proposal before the prescribed date & time using the Digital Signature Certificate (DSC). The Documents are to be uploaded virus scanned copy duly Digital signed. The documents will get encrypted (Transformed into non-readable formats).

Technical Proposal:

The Technical Proposal should have contained scanned copies of the following in two covers (folders).

(a) Statutory Cover Containing the following documents:

- i. Earnest Money (refundable) of **₹52,000/- (Rupees fifty two thousand only)** only will have to be submitted through online in the form of scancopy of NEFT/RTGS challan as per e-procurement portal of the Govt. of West Bengal <http://wbtenders.gov.in> in favour of WEST BENGAL STATE SEED CORPORATION LTD., payable at Malda, are to be documented through e-filing.
- ii. Self Attested Copy of valid GST Certificate, PAN & Aadhaar Card of Indian citizen.
- iii. Self Attested Copy of valid Trade License for Transport work.
- iv. Self Attested Copy of upto date Professional Tax Deposit Challan
- v. Self Attested Blue Book / Smart Card for at least one goods carriage vehicle of his own.
- vi. Self attested copy of Credential certificate for at least **₹10,40,000/- (Rupees ten lakhs fourty thousand only)** on an average per year for any one financial year during last five (5) financial year of any Govt./Semi-Govt. Organization for transportation work.
- vii. N.I.T. (downloads properly and uploads the same digitally signed).

The rate will be quoted in the B.O.Q. Quoted rate will be encrypted in the B.O.Q. under financial Bid. In case of quoting any rate in N.I.T. the Tender is liable to be summarily rejected.

- ii. Power of Attorney (In case of Partnership firm).

Tender Evaluation Committee (TEC)

- Evaluation Committee constituted as per order of the Managing Director, West Bengal State Seed Corporation Limited will function as Evaluation Committee for Selection of technically qualified Contractor.
- Opening & evaluation of Tender:** If any Contractor is exempted from payment of EMD, copy of relevant Government Order needs to be furnished.
- Opening of Technical Proposal:** Technical Proposal will be opened by the Officer-In-Charge, West Bengal State Seed Corporation Limited, Malda and his authorized representative electronically from the website using their Digital Signature Certificate (DSC).
- Intending Tenderers may remain present if they so desire.
- Cover (Folder) for statutory Documents will be opened first & if found in Order. Cover (folder) for non Statutory Documents will be opened, if there is any deficiency in the statutory Documents of the tender summarily be rejected.
- Decrypted (transformed into readable formats) documents of the Non-Statutory cover will be downloaded & handed over to the Tender evaluation Committee.
- Summary list of technically qualified tenderers will be uploaded online.
- Pursuant to scrutiny & decision of the Tender Evaluation Committee the Summary list of Eligible tenderers & the serial No. of work for which their proposal will be considered will be uploaded in the web portals.
- During evaluation the committee may summon the Tenderers and seek clarification / information or additional documents or original hard copy of any of the documents already submitted & if these are not produced within the stipulated time frame, their proposal will be liable for rejection.

FINANCIAL PROPOSAL

- The Financial Proposal should contain the following documents in one cover (folder) i.e., Bill of Quantities (BOQ). The Contractor is to quote the item wise rate online through computer in the space marked for quoting rate in the BOQ.
- Only downloaded copies of the above documents are to be uploaded by virus free scanned & Digitally Signed by the contractor.
Financial Capacity of a bidder will be judged on the basis of information furnished.
- Penalty for suppression /distortion of facts :**
If any tenderers fails to produce the original hard copies of the documents like Completion Certificates & any other documents on demand of the Tender Evaluation Committee within a specified time frame or if any deviation is detected in the hard copies from the uploaded soft copies, it may be treated as submission of false documents by the tenderer & action may be referred to the appropriated authority for prosecution as per relevant IT Act.
- Rejection of Bid :**
