Terms and Conditions

1. Tenders must be submitted by own hand or representative with necessary documents in closed envelop specifying clearly top of the envelop "TENDER FOR SECURITY GUARD IN WBSSC LTD, NADIA" to the undersigned **on 12.12.2019 upto 01.00 p.m. and will be opened on the same date at 1.30 p.m.** The last date of accepting tender and date of opening may be shifted to the next working day in unavoidable circumstances.
2. The Agency/Contractor intended to apply must have experience in this type of works to any Government Organizations / Government Farms / reputed organizations.
3. The Agency / Contractor intended to apply must have all the documents related to legality office bid failing which the Principal Employer reserves the right to cancel/rescind the bid without any further notice to the bidder, even if his bid is lowest.
4. Monthly emoluments (without GST) of security guard per head for 8 (eight) hours should be clearly quoted in figures and words in Tender.
5. All the statutory norms regarding contract labour license, EPF, ESI as applicable have to be mentioned by the bidders in Tender.
6. Tender should be accompanied with self attested photocopy of the valid license from the Govt. of West Bengal under Private Security Agencies (Regulation) Act, 2005, Trade License, PAN Card, Latest Income Tax Return, EPF Registration Certificate, GST Certificate (if applicable), Registration Certificate of Shops & Establishment Act, 1963, P. Tax Registration Certificate, work orders of valued clients.
7. Rate quoted should confirm all the existing rules of Labour Act, West Bengal.
8. Tender should be accompanied with **original Demand Draft of Rs.6,000.00 (Six Thousand) only** drawn in favour of "W. B. State Seed Corporation Ltd.", payable at Krishnagar from any nationalized banks as Earnest Money. **The Earnest Money of the successful bidder will be treated as Security Deposit.**

11. An Agreement Bond will be made in Non Judicial Stamp Paper of Rs.10/- (Rupees Ten) only between the successful bidder and WBSSCL, Krishnagar, Nadia. The successful bidder will arrange for the agreement.
12. The Authority reserves the right to cancel the agreement of service rendered by the Security Agency is found to be unsatisfactory or due to any other reason with one month's notice.
13. Allotment / Placement of the engaged security guards / personnel will be done by the office of the undersigned.
14. Payment will be made through account payee cheque after deducting applicable statutory taxes. The GST number of successful bidder should be clearly mentioned on the bill.
