Tenders must be dropped in the tender box kept in the office of the District Manager, W.B.S.S.C Ltd., Krishnagar, Nadia on all working days up to **01.00 p.m. on 05.10.2018** and will be opened on **the same date at 02.00 p.m.** The last date of accepting tender and date of opening may be shifted to the next working day in unavoidable circumstances.
3. Tender should be accompanied with **original Demand Draft of Rs.10,000.00 (Ten Thousand)** only drawn in favour of **"W. B. State Seed Corporation Ltd."**, payable at Krishnagar from any nationalized banks as Earnest Money.
4. The Earnest money of successful tenderer would be adjusted against the value of the final consignment.
5. The intending tenderer must submit self attested Xerox copy of **Pan Card, Aadhar Card, Trade License and GST Certificate (if applicable).**





6. The successful tenderer i.e. H₁ bidder has to be lifted the entire stocks within 7 (seven) days from the date of order of the under signed.
7. The authority reserves the absolute right to accept or reject any or all tenders without assigning any reason whatsoever.
8. The successful tenderer will have to make their own arrangement for lifting of the stock within the stipulated time at their own cost from the godown.
9. In case the tender is accepted, the tenderer will have to execute an agreement in non-judicial stamp paper of Rs.100/- stating that the stocks will not be used for seed purpose as well as human & cattle feed purpose as the stock has treated with seed treatment chemicals. The successful bidder will arrange for the agreement.
10. All charges of transport, weightment, loading, unloading and labour charges etc would be borne by the tenderer.
11. The stock would be weighted along with gunny bags and the rate offered per quintal would be inclusive of bags in which the substandard seeds are packed.
12. In case of any litigation, the matter will be referred to Kolkata High Court Jurisdiction.


